FEES AND CONDITIONS:

- All Commercial Marina operators shall pay an annual license fee.
- Licenses shall commence on May 15 and end on October 15 of each calendar year; License fees shall not be pro-rated. Owner may occupy their slips from May 1 through October 31 for additional charge.
- The license is not transferable from person to person or business to business.
- Boating operations shall comply with Wisconsin Department of Natural Resources.
- Owner acknowledges that the Egg Harbor Marina is public property.
- The total number of licenses issued by the Village shall be limited to one (1). The Village Board reserves the right to change this limitation by resolution.

PHOTOCOPIES OF THE FOLLOWING MUST ACCOMPANY THE APPLICATION:

- A valid copy of all necessary licenses for the operation of the business including, but not limited to, licenses or certificates required by Door County, the State of Wisconsin, or any subsidiary enforcement agencies or departments thereof.
- WI Seller's Permit Number
- Boat Registration/Title
- Declaration of coverage of public liability insurance, of not less than \$1,000,000 which shall name the Village of Egg Harbor as an additional insured.
- Signed Operating/Lease Agreement
